Waiver & Release of Liability

Please thoroughly review the following information and initial acknowledgement of each section of this agreement.

- I understand that my child will be participating in activities at the Maclean-Cameron Animal Adoption Center and in the course of such activities my child may encounter direct or indirect contact with domestic animals.
- I further understand that the behavior of animals is sometimes unpredictable, and that some animals are capable of inflicting personal injury. I understand that my child's participation in activities at Maclean-Cameron Animal Adoption Center involves certain risks, including but not limited to serious injury and death. Knowing the risks of handling or coming in contact with animals, on behalf of the minor and myself, I agree to assume those risks and to absolutely and unconditionally release, indemnify, hold harmless and forever discharge the Maclean-Cameron Animal Adoption Center and/or any of its officers, directors, employees, agents, affiliates, sponsors or contractors from any and all personal injury and property damage resulting from my child's participation in activities at the Maclean-Cameron Animal Adoption Center.
- I agree to pay for all damages to the facilities and grounds of the Maclean-Cameron Animal Adoption Center caused by any negligent, reckless or willful actions of my child.
- I have explained to my child that he or she must observe and obey all rules and warnings, and further agrees to follow any oral instructions or directions given by Maclean-Cameron Animal Adoption Center staff, representatives, agents or the designated adult chaperones of the facility reenter(s)/party host(s).
- I also understand that my child is to remain on the Maclean-Cameron Animal Adoption Center property for the duration of the activities. If my child leaves the property during participation, with or without permission from a staff member, I also release, indemnify and hold harmless the Maclean-Cameron Animal Adoption Center from any and all personal injury and property damages resulting from my child leaving the Maclean-Cameron Animal Adoption Center property.
- I know of no medical or other condition that would prevent my child from full or safe participation in activities at the Maclean-Cameron Animal Adoption Center.
- Effective as of the date shown below, I hereby grant permission for photographs to be taken of my child to be used in present and future marketing items for the Maclean-Animal Adoption Center. Use is being granted to the Maclean-Cameron Animal Adoption Center its agents, employees, licensees, and successors in interest (collectively, the "Released Party") all ownership rights and the absolute and irrevocable right and permission to copyright, use and publish the photo or other image of said child. The likeness may be copyrighted, used and/or published

individually or in conjunction with other photography or video works, and in any medium (including without limitation, print publications, public broadcast, CD-ROM format) and for any lawful purpose, including without limitation, trade, exhibition, illustration, promotion, publicity, advertising and electronic publication. The undersigned represents and warrants that (i) no other party has been granted an exclusive license with respect to the Likeness, and (ii) no other party's authorization or consent is required with respect to the permission granted to the Released Party under this Waiver and Release. The undersigned waives any right that the undersigned, the Photographed Party, or any party related to the Photographed Party may have to inspect or approve the Released Party's copyright, use or publication of the Likeness, or the advertising copy or printed matter that may be used in connection with the copyright, use and/or publication of the Likeness.

The undersigned, on behalf of the undersigned, the Photographed Party, and any other parties related to the Photographed Party, releases the Released Party (and all persons acting under its permission or authority) from all claims for libel, slander, invasion of privacy, infringement of copyright or right of publicity, or any other claim related to the Likeness (collectively, "Claims").
